USF Undergraduates should sign up for the 4+3 Program as soon as possible (there are no prerequisites), and preferably by the end of the spring semester of their sophomore year. **Students must formally declare either their Legal Studies or Criminal Justice minor using the “Change of Academic Program” form and have their advisor or the Program Assistant add the 4+3 Program as a Special Program on the form.** Transfer students should sign up for the Program as soon as possible after they begin USF.

To SATISFY the 4+3 BA/BS – JD Law Program (and earn automatic admission to the USF Law School), I understand that:

- I must have a cumulative GPA of at least 3.2 for all my course work. \_\_\_\_\_
- I must declare and complete either the Legal Studies Minor or the Criminal Justice Studies Minor. \_\_\_\_\_
- I must score at least 56% on the LSAT; and if I take the LSAT more than once, I understand that **the HIGHEST of the scores** will be used to determine my eligibility. (WE STRONGLY URGE YOU TO TAKE THE LSAT NO LATER THAN THE OCTOBER TEST DATE IN THE YEAR PRIOR TO YOUR DESIRED ENROLLMENT, IN CASE YOU WANT TO REPEAT IT IN DECEMBER. ) (NOTE: THE LAW SCHOOL ACCEPTS STUDENTS ONLY FOR THE FALL SEMESTER IN ANY GIVEN YEAR). \_\_\_\_\_
- I must submit my completed Application for Enrollment to the USF Law School (using the regular admissions form) NO LATER than the PRIORITY DEADLINE (currently February 1), and I must write “4+3 APPLICANT” on my application. If I apply online, I will check the “Other” box and type in “4+3 APPLICANT,” and be refunded for the application fee. \_\_\_\_\_
- I understand that I must also satisfy all other requirements for applying to the USF School of Law, including the submission of a personal statement, two letters of recommendation, and a LSDAS Report with a VALID LSAT score(s). \_\_\_\_\_
